- Contractors/ Service providers shall have valid GST no. if available & PAN No. Copy of the same may please attached.
- Rates Shall be inclusive of GST & other Taxes, if any and Installation. Transportation of the material will be liability of the Contractor / Service provider.
- The site for lighting may change as per requirement of Engineer-in-Charge.
- All necessary connectiong Cables/ wires has to be provided by Contractor. Only Location Electrical supply point will be given by NEERI.
- You will use the material strictly as per IS specification or as approved by Institute.
- Trial should be given on 25<sup>th</sup> Jan. 2024 for Main building & Gate 1 & Gate 2.
- All safety precautions should be taken for human beings, building, plants, machineries, etc.
