

# Vigilance Awareness

The role of vigilance is to protect the organization from internal dangers which are more serious than external threats. Vigilance in any organization is an integral function like any other function of administration/management, such as finance, personnel, purchase, and contracts etc. Vigilance angle is matters related to officers/employees involvement in the following acts: - (i) Demanding and/or accepting gratification other than legal remuneration in respect of an official act or for using his influence with any other official.

Vigilance Cases are registered by the department/ Officers after getting sanction from the Director of the Institute, based on the evidence available. The Director shall collect information on corruption and corrupt officials and process it with utmost confidentiality.

Vigilance is of three types - preventive, participative and punitive. Preventive vigilance involves studying the organization, its policies and its people; and implementing effective measures so that these do not become vulnerable to corruption.

## Observance of Vigilance Awareness Week (VAW-2020)

As per CVC Circular No. 09/09/2020 (020/VGL/036/459673) dated 08.09.2020 endorsed by CSIR vide their letter No. 15-6(88)/2001-O&M (Vol X) dated 15.09.2020 the observance of Vigilance Awareness Week in our Council will commence from 27th October to 2nd November, 2020.

## Theme (VAW-2020)

The Central Vigilance Commission, which has a special responsibility under para 3(v) of Government of India Resolution no 371/20/99/AVD-III dated 4.4.1999, declared that the week beginning from 31st October every year should be observed as the Vigilance Awareness Week. Vigilance Awareness Week (VAW) is being celebrated every year and coincides with the birthday of Sardar Vallabhbhai Patel, known to be a man of high integrity. The purpose of Vigilance Awareness Week is to generate awareness in the public at large about the ill effects of corruption.
